Awards Overview

In 2026, CITT is accepting applications for three corporate awards:

1. Excellence in Innovation
2. Environmental Sustainability
3. Employer of the Year

As Canada's Logistics Association, CITT aims to recognize excellence in transportation and logistics in particularly, including in "shipper" side businesses that have a significant supply chain function, businesses that offer supply chain transportation, logistics and distribution services, as well as businesses that serve the sector with ancillary products and services.

While any organization is welcome to apply for a CITT Corporate Award, the Awards Evaluation Committee considers it a significant asset for an application to show a clear connection between the activities and achievements described in their application and their transportation/logistics operations or product/service lines in particular.

There will be two categories per award:

- 1) **SME** – Enterprises with 500 or fewer Canadian-based employees
- 2) **Large Scale Enterprises** – Corporations with 500 + Canadian-based employees

Applicants are asked to please submit **1 separate application per award (if your organization is NOT a CITT Endorsed Business Partner or Endorsed Logistics Employer, an application fee will be charged per application)**.

The Awards Evaluation Committee retains discretion to NOT issue an award in a specific category, if quality of candidates' applications is not sufficient and do not meet criteria outlined

Criteria considered in selection of the winner for each award is as follows:

Excellence in Innovation

The winning company demonstrates a continued commitment to being at the forefront of business in the industry. Through product and/or service development, organizational practices, or approach to business, this business has shown that innovation is central to its identity.

Criteria Include:

- Significant company growth from new products/sustained success in launching product/service
- Well defined new product development practices and processes that can be adequately described to others
- Distinctive innovative characteristics and intangibles, including culture

Environmental Sustainability

The winning company has made sustainability an integral part of their business practice and has demonstrated creativity, capability and leadership in the implementation of environmental stewardship and the promotion of sustainable development. CITT wishes to recognize companies who are working tirelessly to transform their operations and supply chain to be carbon neutral or net zero, showcasing their leadership in putting nature and decarbonization at the heart of their business.

Criteria Include:

- Clear examples of inspiring decisions the company has taken to reach carbon neutral/net zero
- Metrics and data that showcase how the business is on track to hit its carbon neutrality and/or net zero target
- Evidence highlighting how this leadership has positively impacted the business and the communities they operate within

Employer of the Year

Education and skills development are integral to the improvement of any business or individual professional. Upskilling and re-skilling can also help employers cut costs by investing in existing talent rather than hiring new employees to compensate. Training and education are the catalyst for achieving all professional development goals.

This award recognizes organizations that actively promote a culture of employee growth and development - building talent enterprise-wide and strategically driving a talent development culture within.

Criteria Include:

- Investment and commitment to professional development, continuous improvement, and nurturing of employees' abilities
- Learning has value in the organization's culture: learning opportunities for employees, C-level involvement, learning for growth of the organization, and innovation
- Culture beyond professional development, including employee engagement, benefits/work-life balance, and employee satisfaction
